VâRi series V2218S is perfect for musicians, DJs, and anyone needing a flexible, portable subwoofer.

- Sleek and rugged steel grille
- Heavy-duty casters and balanced side handles
- Sturdy 1 3/8" pole mount

Please keep this instruction manual for future reference and for the duration of owning the VâRi powered loudspeaker. Please carefully read and understand the instructions inside this owner's manual before attempting to operate your new powered loudspeaker.

This instruction manual includes essential safety information regarding the use and maintenance of the amplifier. Take special care to heed all warning symbols and signs inside this manual and those printed on the amplifier on the back of the loudspeaker.

WARNING

TO PREVENT FIRE OR SHOCK HAZARD, DO NOT EXPOSE THE AMPLIFIER TO WATER/MOISTURE, NOR SHOULD YOU OPERATE THE AMPLIFIER NEAR ANY WATER SOURCE.

The exclamation point triangular symbol is intended to alert the user to the presence of important operating and maintenance(servicing) instructions in the user manual accompanying the Amplifier.

The lightning flash with an arrow triangular symbol is intended to alert the user to the presence of non-insulated "dangerous voltage" within the product's enclosure, and may be of sufficient magnitude to constitute a risk of electric shock.

WARNING

Handle the power supply cord with care.

Do not damage or deform it as it may cause electric shock or malfunction when used. Hold the plug attachment when removing from wall outlet. Do not pull on the power cord.

IMPORTANT SAFETY PRECAUTIONS

- 1. READ INSTRUCTIONS All the safety and operating instructions should be read before this product is operated.
- 2. RETAIN INSTRUCTIONS The safety and operating instructions should be retained for future reference.
- 3. HEED WARNINGS All warnings on the amplifier and in the operating instructions should be adhered to.
- FOLLOW INSTRUCTIONS All operating and use instructions should be followed.
- 5. DO NOT turn on the VâRi amplifier module before connecting all other external devices.
- 6. WATER AND MOISTURE Moisture can damage the VâRi amplifier module and can cause corrosion of electrical contacts. The speaker system should not be used near water - for example, a bathtub, washbowl, kitchen sink, laundry tub, wet basement, or near a swimming pool, and the like.
- 7. CARTS AND STANDS The speaker system should be used only with a cart or stand that is recommended by the manufacturer. A speaker and cart combination should be moved with care. Quick stops, excessive force, and uneven surfaces may cause the speaker and cart combination to overturn.
- 8. WALL OR CEILING MOUNTING The product should never be mounted to a wall or ceiling.
- HEAT The loudspeaker on the back of the VâRi loudspeaker should be situated away from heat sources such as radiators, heat registers, stoves, or other sources (including amplifiers) that produce heat.

- POWER SOURCES This product should be operated only from the type of power source indicated on the rating label. If you are not sure of the type of power supply to your home, consult your product dealer or local power company.
- 11. GROUNDING OR POLARIZATION Do not defeat the safety purpose of the polarization or grounding-type plug. The wide blade or the third prong is provided for your safety. If the provided plug does not fit your outlet, consult an electrician for replacement of the obsolete outlet. Do not defeat the safety purpose of the 3rd pin grounding prong.
- 12. POWER-CORD PROTECTION Power supply cords should be routed so that they are not likely to be walked on or pinched by items placed upon or against them, paying particular attention to the cord in correspondence of plugs, convenience receptacles, and the point where they exit from the amplifier.
- CLEANING The speaker and amplifier should be cleaned only as recommended by the manufacturer. Clean by wiping with a dry cloth. Avoid getting water inside the speaker or amplifier.
- 14. NON-USE PERIODS The power cord of the amplifier should be unplugged from the outlet when left unused for a long period of time.
- OBJECT AND LIQUID ENTRY Care should be taken so that objects do not fall and liquids are not spilled into the enclosure through openings.
- DAMAGE REQUIRING SERVICE The amplifier should be serviced by qualified service personnel when:
 - A. The power supply cord or the plug has been damaged; or
 - B. Objects have fallen, or liquid has been spilled into the amplifier; or
 - C. The amplifier has been exposed to rain; or
 - D. The amplifier does not appear to operate normally or exhibits a marked change in performance; or
 - E. The amplifier has been dropped, or the enclosure damaged.
- 17. Keep the speaker system out of extended or intense direct sun light.
- No containers filled with any type of liquid should be placed on or near the speaker system.
- 19. SERVICING The user should not attempt any service to the speaker and/or amplifier beyond that described in the operating instructions. All other servicing should be referred to qualified service personnel.
- 20. VENTILATION Slots and openings in the amplifier are provided for ventilation and to ensure reliable operation of the product and to protect it from overheating. These openings must not be blocked or covered. The openings should never be blocked by placing the product on a bed, sofa, rug, or other similar surface. This product should not be placed in a built-in installation such as a bookcase or rack.
- 21. ATTACHMENTS do not use attachments not recommended by the product manufacturer, as they may cause hazards.
- 22. ACCESSORIES Do not place this product on an unstable cart, stand, tripod, bracket, or table. The product may fall, causing serious injury to a child or adult, and serious damage to the product. Use only with a cart, stand, tripod, bracket, or table recommended by the manufacturer, or sold with the product.





- 23. LIGHTNING For added protection during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet. This will prevent damage to the product due to lightning and power-line surges.
- 24. REPLACEMENT PARTS When replacement parts are required, be sure the service technician has used replacement parts specified by the manufacturer or have the same characteristics as the original part. Unauthorized substitutions may result in fire, electric shock, or other hazards.
- 25. SAFETY CHECK Upon completion of any service or repairs to this product, ask the service technician to perform safety checks to determine that the product is in proper operating condition.
- 26. FUSES Always use the correct rating and type of fuse as indicated on the rear panel of the amplifier. Note the proper rating fuse is determined by the AC line voltage in the country this speaker system is being operated. COMPLETELY DISCONNECT POWER CORD FROM AMPLIFIER BEFORE ATTEMPTING TO REPLACE FUSE!
- 27. HARBINGER VÂRI SERIES POWERED LOUDSPEAKERS ARE NOT DESIGNED FOR TEMPORARY OR PERMANENT SUSPENSION. ANY ATTEMPT TO SUSPEND A VÂRI SERIES CABINET COULD RESULT IN INJURY OR DEATH.

To prevent electric shock, do not use a polarized plug with an extension cord, receptacle or other outlet unless the blades can be fully inserted to prevent blade exposure.

QUICK START GUIDE

SETTING UP/HELPFUL TIPS

- Position the VâRi speaker in the desired location, and ensure the speaker is stable.
- Make sure the Power Switch is OFF.
- Make certain Level knob is turned down.

MAKING THE CONNECTIONS

Plug connections to INPUT 1 and 2 from OUTPUTS of signal source.

POWERING UP

- Turn on the power to any devices plugged into Input 1 or Input 2.
- Power ON the speaker.


- Slowly turn the Level knob to 12 o'clock.
- Slowly turn up the source volume to the desired level.

SIG/CLIP LIGHT

• The SIG/CLIP LED will light up BLUE when the speaker is receiving a signal. If it is distorting, the LED will turn RED and the MASTER VOLUME should be turned down.

LINKING MULTIPLE SUBWOOFERS

- If linking multiple subwoofers, plug the Line OUTPUT connection of speaker 1 to the INPUT connection of speaker 2, and continue the daisy chain to the next speaker.
- Turn the Power ON in the order of the audio signal to prevent unwanted "pops". First ON / Last OFF.





OUTPUTS 1 AND 2

When set to CROSSOVER, the XLR jacks will send the signal coming from the input through the built-in crossover. You can also select the crossover frequency. The output signal should then be used to play the filtered frequencies with your standard full frequency speakers. When set to LINK, the crossover function is disabled.

2 INPUTS 1 AND 2

These combo inputs are designed for either TRS and XLR balanced plugs at line level either from a mixer or another speaker. The source can either be stereo or mono.

3 CROSSOVER LINK SELECTION SWITCH

Switches between the internal CROSSOVER or the LINK mode to send the inputs directly to the outputs.

4 CROSSOVER SWITCH SELECTOR

This switch will determine the crossover point where the high pass filter will be set to output high frequency content to the outputs. The lower frequencies under the crossover point will be played by the internal speaker in the subwoofer.

5 LED DEFEAT SWITCH

The front-mounted LED has two functions. This switch toggles between those functions.

- ON position = Front-mounted LED indicates when power is on.
- S/L position = Front-mounted LED indicates when the limiter is engaged. (If LED turns red in this position, the speaker is distorting.)

6 PHASE SELECTION SWITCH

The Phase switch lets you alter the polarity of the input signal. When the Phase switch is in its default "O" setting, phase is unaffected.

7 LEVEL

This knob affects the volume of the internal speaker.

8 SIGNAL INDICATOR

The SIG/CLIP LED will light up BLUE when the speaker is receiving a signal. If it is distorting, the LED will turn RED and the MASTER VOLUME should be turned down.

9 POWER LED

The Power LED indicates that the VâRi speaker's AC power cord is connected to an electrical outlet, and the Power Switch is turned on.

IEC POWER INPUT

Plug in the IEC AC cable here.

POWER SWITCH

Turns the VâRi subwoofer ON or OFF.
